WHEREAS, the Authority now desires to submit an application to the Local Finance Board within the Division of Local Government Services, New Jersey Department of Community Affairs ("Local Finance Board") for its review of a proposed supplemental resolution authorizing the Authority to permanently finance the Project through the State Fiscal Year 2025 Spring Bond Pool via a thirty (30) year loan from the New Jersey Infrastructure Bank and the State of New Jersey, acting through the New Jersey Department of Environmental Protection, via the I-Bank's New Jersey Water Bank Environmental Infrastructure Financing Program under N.J.S.A. 58:11B-9(a); and
